A Summary of the Economic Impact for major events at the Georgia World Congress Center and the Georgia Dome during July was reviewed. Total attendance for July events was 179,883. New dollars generated by out-of-town visitors were \$115.6 million and estimated total economic impact was \$187.7 million. Estimated State sales tax generated was \$8.1 million.

Chair Prather thanked Mr. Mellin for his report and then called on Sherrie Spinks for the review of the July 2010 financial reports, which are appended and made a part of these minutes.

Note: July is the first month of this fiscal year. Therefore, YTD totals are the same as monthly totals.

GEORGIA WORLD CONGRESS CENTER

Operating revenue for July was \$2,323,187 against a budget of \$2,023,414, which was \$299,773 or 14.81% **ahead** of forecast for the month. The increase is mainly due to food and beverage and utilities revenue. Total expenditures of \$2,744,374 were \$59,184 or 2.11% **under** budget. The Congress Center projected a net loss of (\$780,144) but had an actual net loss of (\$421,187) for the month, which is \$358,957 better than forecast.

GEORGIA DOME

Total operating revenue for July was \$21,829,940 against a budget of \$24,441,448, which was \$2,611,508 or 10.68% **below** forecast. Operating expenditures of \$1,900,592 were \$258,932 or 11.99% **under** budget. The Dome projected a net profit of \$22,281,924 but had an actual net profit of \$19,929,348 for the month.

Note: Receipts for annual Suites, Club Seats, and Advertising License Fees typically are received at the first of each fiscal year. Through a timing for recognition of July revenue, these revenue categories were not credited with all funds received. August financials should reflect budgeted performance.

CENTENNIAL OLYMPIC PARK

Operating revenue for July was \$929,552 against a budget of \$941,138, which was \$11,586 or 1.23% **below** forecast. Operating expenditures for the month were \$730,432, which was \$36,376 or 4.74% **less** than projected. The Park projected a net gain against budget of \$174,330 for the month, but had an actual **net gain** of \$199,120.

GOOGIE BURGER UPDATE

Mark Banta, General Manager of Centennial Olympic Park, thanked the GWCCA Centennial Olympic Park Committee for all of its input and support in the development process for the Park's new food service venue, The Googie Burger. Mark introduced the Levy team that manages the Googie Burger, Chef John Coley and General Manager Shawn Goelz. They have done a terrific job since it opened in July.

The original concept for a new food service venue was to establish an iconic destination that was fun for families and visitors; and we knew we needed to make the building more accessible. The Googie Burger building replicates a style of architecture reminiscent of the 1950's. We feel that with the use of this style of architecture, we have met our objective to create something of interest for the people. The Fountain of Rings now flows into the open area surrounding the Googie making the building very approachable. At night the building lights up drawing in a more adult crowd.

Levy Innovations in Chicago took the food service concept into the "restaurant world" with burgers, chicken sandwiches, and shakes with friendly, fast, service. Adult meals are available for approximately \$8.50 and children's meals are under \$5.

We hope to make the Googie burger the new restaurant destination. After being open for only forty-five days, we are seeing the potential to build a new tradition of the place to eat before and after events. We have already seen large numbers, sixty-five to seventy, CNN employees coming to the Googie Burger for lunch. Core area business is what will make us successful,

The Googie Burger opened July 13 and in that eighteen day period, revenue of \$41,584 was 51% more than that time last year. The month of August brought in revenue of \$49,538, an increase of 142% over last year's August sales. We think the Googie Burger has incredible potential. We are very excited about its future. We hope everyone enjoyed their Googie Burger lunch today and please, spread the word.

Chair Prather thanked Mark and Levy for today's wonderful food.

The Authority Planning Retreat will take place September 27 and 28 in place of the regular September Authority meeting. The next regular Authority meeting will be October 26, 2010.

Chair Prather then called for a motion to adjourn to Executive Session to discuss personnel issues.

Motion to move to Executive Session to discuss personnel issues was made by Doug Tollett, seconded by Glenn Hicks, and unanimously approved.

Motion to move out of Executive Session and reconvene to General Session was made by Lee Hunter, seconded by Ken Cornelius, and unanimously approved.

Chair Prather then asked for a motion to adopt the full report of the GWCCA Employee Compensation Committee.

Motion to adopt the full report of the GWCCA Employee Compensation Committee was made by Taz Anderson, seconded by Doug Tollett, and unanimously approved.

Mr. Poe informed board members that the planning retreat will be an engaged day and a half. The first part of Monday morning will be spent on internal updates and Doug Ducate will report on the state of convention hall industry and the future of the industry. Monday afternoon will be spent on Dome stadium issues. Tuesday Rich McKay will give a brief presentation followed by a Q&A session. After Mr. McKay's report there will be a brief wrap up session. Governor Perdue may join the group for dinner Monday evening.

With no further business to discuss, a motion to adjourn was made by Glenn Hicks, seconded by Taz Anderson, and unanimously approved.
