TERMS

1. This permit must be displayed at the designated area or carried by a present participant onsite at all times during which the activity permitted is conducted.
2. Persons engaging in the activity allowed under this permit shall not obstruct or impede pedestrians or vehicles, harass visitors with physical contact or persistent demands, or misrepresent the purpose or affiliations of those engaged in the activity.
3. The permittee shall not use any noise making devices, sound/voice amplifying apparatus, shouting, singing, or other offensively boisterous conducts interfering with the intended purpose of the facilities of the Authority or the reasonable enjoyment thereof by attendees at an event.
4. Permittee agrees to make a reasonable effort to clean the area around the designated distribution area of any litter created by the activity before exiting the area at the end of the designated time.
5. Permittee agrees to indemnify and hold harmless to the Georgia World Congress Center Authority, its members, officers, employees, and other representatives, from any loss or liability arising out of the permittee's activities at the designated distribution areas.
6. No permittee shall solicit or accept funds or offer any merchandise or goods of any kind for sale.
7. Violation of the terms and conditions of a permit issued in accordance with regulations may result in the suspension or revocation of the permit. Failure to enforce any terms and conditions on any occasion shall not constitute a waiver or modification of the permit terms.
