A motion to approve the Resolution authorizing the Department of Economic Development submit a request to the Georgia State Financing and Investment Commission that the Commission undertake to issue \$12,000,000 in aggregate principal amount of State of Georgia General Obligation Bonds, a copy of which is attached as Exhibit C, was made by Brian Robinson, seconded by Doug Tollett, and unanimously approved.

EXECUTIVE SESSION

A motion to move into Executive Session to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee, or interviewing applicants for the position of the executive head of an agency was made by Brian Daniel, seconded by Bill Jones, and unanimously approved.

Glenn Hicks reported the Board recommends approval to implement the following items, which were approved by the Board at the July 28, 2020 Board of Governors meeting, in light of the improvement to the business environment and business volume.

- (1) To award to Executive Director, as per his contract, an Annual Performance-Based Compensation of 20% of his base salary for his successful FY20 performance.
- (2) To approve a 5% increase in the Executive Director's base salary effective July 1, 2020.

A motion to approve implementing the action taken by the Board at the July 28, 2020 Board of Governors meeting as it relates to the Executive Director's FY20 annual performance-based compensation and base salary increase was made by Bill Jones, seconded by Doug Tollett, and unanimously approved.
