

### **Overview**



#### Focus

Turf management, seasonal planting, fertilizing, chemical weed control, irrigation/hand watering, grooming/trimming, soil/tissue sampling, debris removal, tree management, inclement weather response

#### Scope

GWCCA to partner with Landcare USA to provide landscape maintenance services to include but not limited to mowing, watering, fertilizing, weeding, spraying, policing, edging, mulching, re-seeding, re-sodding, irrigation, and pruning all exterior grounds of GWCCA's campus and Centennial Olympic Park (COP)

#### Term of Contract

- ≻ Term: 3 years (2025-2028) with two 1-year options to extend
- SWCCA main campus: \$343,910 (annual) / \$28,659 (monthly); excludes Signia by Hilton and MBS
- > COP: \$203,472 (annual) / \$16,956 (monthly)

### **Overview**



#### Focus

> To provide consistent comfort; prevent system failure; and maximize energy efficiency

#### Scope

- > Preventive maintenance on 245 air handler units (AHUs) and 97 power induction units (PIUs)
- ▶ Replace all filters on all equipment with MERV 13 filters to maintain LEED Gold certification
- Grease all fittings on bearings and motors
- ➢ Replace or tighten belts as needed
- Clean each condensation drain/pan
- Visual inspection on coil and exterior housing of equipment

#### Term of Contract

- > One year, with option to extend for one additional year
- ▶ \$415,140 or \$34,595 per month

- > 2018: Certified Sports Security Professional (CSSP) certification


#### ➤ 2022: transitioned to GWCCA as security manager
