CENTENNIAL OLYMPIC PARK REOPENS ICONIC FOUNTAIN OF RINGS WITH MODERNIZED FEATURES AND DAILY SHOWS

Project Funded by Generous \$2.5 Million Grant from the Robert W. Woodruff Foundation

ATLANTA – Georgia World Congress Center Authority (GWCCA) today announced the reopening of the iconic Fountain of Rings at Centennial Olympic Park, featuring cutting-edge enhancements that elevate the visitor experience. Thanks to a generous \$2.5 million grant from the Robert W. Woodruff Foundation, the beloved landmark now boasts modernized features designed to create an immersive audio-visual experience.

Beginning the week of March 10, visitors can enjoy four spectacular daily shows at 12:00 p.m., 2:30 p.m., 6:30 p.m., and 9:00 p.m.

During show performances, guests will see water spray heights over 15 feet, more than 250 new LED ring lights offering stunning 360° illumination in vibrant colors and patterns (evening shows only), and a sophisticated fog system with over 200 individual fog emitters, all synchronized to an exciting new musical lineup.

The choreographed water show set to music includes a curated playlist of songs from artists with ties to Georgia or GWCCA's campus, timeless classics, and a few surprises, creating an engaging and memorable spectacle for all ages. Songs include "Hey Ya!" by Outkast, "Shake It Off" by Taylor Swift, "Tiny Dancer" by Elton John, "Thriller" by Michael Jackson, "Reach" by Gloria Estefan, "Living in America" by James Brown, "Chicken Fried" by Zac Brown Band, "We Don't Talk About Bruno" from the movie *Encanto*, "Can't Stop the Feeling" by Justin Timberlake, and "Georgia on My Mind" by Ray Charles.

"The Fountain of Rings is a signature attraction in Centennial Olympic Park, and these upgrades further enhance its status as a must-see destination in downtown Atlanta," said Kevin Duvall, chief executive officer, GWCCA. "We are grateful to the Woodruff Foundation for their continued support of the park over the years and for making this project a reality, ensuring the Fountain continues to inspire and delight visitors for years to come."
